RECOMMENDED ACTION

Recommendation: That the City Council:

1. Adopt Resolution No. 2017-XX, a Resolution of the City Council of the City of Moreno Valley, California, reciting the fact of the Special Municipal Election held on June 6, 2017, declaring and certifying the results and such other matters as provided by law.

SUMMARY

Pursuant to Sections 10262 and 10263 of the California Elections Code, the elections official shall certify the results to the governing body and the governing body shall adopt a resolution reciting the fact of the election, declaring the official results and such other matters as provided by law, no later than the next regularly scheduled City Council meeting following presentation of the canvass, or at a special meeting called for that purpose. The official canvass of the election is expected to be received on June 15, 2017. Adoption of the proposed resolution will comply with these requirements.

DISCUSSION

On Tuesday, June 6, 2017, the City of Moreno Valley conducted a Special Municipal Election for the purpose of electing a Council Member for the vacancy in District 4.

The Riverside County Registrar of Voters has completed the canvass of the election as provided in Chapter 4 of the California Elections Code, which is attached hereto as

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON JUNE 6, 2017, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Moreno Valley, California, on Tuesday, June 6, 2017 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed, and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Riverside County Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A";

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of precinct votes (ballots) and valid provisional ballots cast in District 4 except the *vote by mail* voter ballots was _____. That the whole number of *vote by mail* voter ballots cast in District 4 was _____, making a total of _____ votes (ballots) cast in the City.

SECTION 2. That the names of persons and the offices for which they were voted for at the election are as follows:

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates, and for and against the measure were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that _____ was elected as Council Member for District 4 for a short term expiring following the November 2018 election.

SECTION 5. That the City Clerk shall enter on the records of the City Council of the City, a statement of the results of the election showing: (1) the whole number of votes (ballots) cast in District 4; (2) the names of the persons voted for.

SECTION 6. That the City Clerk shall immediately make and deliver to the person elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. The person elected shall then be inducted into office as elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
